COMES NOW, Plaintiff, REZA GANJAVI, and, as against each of the Defendants named herein, respectfully complains, avers and alleges as follows:

JURISDICTION

1. This action arises under four (4) Federal Statutes and other laws, including the Identity Theft and Assumption Deterrence Act of 1998 (18 U.S.C. § 1028 amended). This Honorable Court has jurisdiction thereunder.

SYNOPSIS

- 2. Plaintiff is a record producer and classical musician who has produced some very successful CD's in the Classical Guitar genre. He has attracted the envy and hostility of certain individuals on a Classical Guitar Internet group. The Defendants have broken a number of laws by attacking the Plaintiff and his business in several vulgar, uncivil, profane, and highly damaging manners, apparently motivated by jealousy, prejudice, and causeless hatred. In performing these above actions the Defendants evidenced malice, fraud, oppression, calculated falsehoods, and disregard for the rights and safety of the Plaintiff. Plaintiff did everything to avert legal action but Defendants opted otherwise.
- In summary,
 - a) Defendants attempted to assassinate Plaintiff's character;
 - b) Defendants committed numerous counts of identity theft / fraudulent use of Plaintiff's identity;
 - c) Defendants fraudulently published material using the Plaintiff's email and name including threatening others with fatal violence, using

- racial slurs against Blacks, and sympathizing with violent, extremist criminals and ideologies;
- d) Defendants setup mock websites to damage Plaintiff's business and reputation;
- e) Defendants published fictitious, forged, altered material which were falsely attributed to the Plaintiff as the author;
- f) Defendants published material which placed the Plaintiff in a highly offensive light;
- g) Defendants copied and published Plaintiff's work without his permission;
- h) And other acts which are explained hereinafter and backed by almost 100 pages of evidence (Exhibit 5).

PLAINTIFF BACKGROUND AS RELATED TO THE CASE

4. Plaintiff, REZA GANJAVI is, and at all relevant times was, a classical guitarist, singer, record producer, and promoter whose music is sold in the form of compact disks (CD's) and digital files. His CD's are marketed worldwide on the Internet through his own website: www.rezamusic.com, other online shops, and certain brick-and-mortar record shops. Plaintiff's most famous CD is entitled "In Friendship" (Exhibit 1) and it was deemed as a best seller in the Classical Guitar genre. Plaintiff's second CD is entitled "Dancing Hands" (Exhibit 1) and it includes guest artists such as the renowned classical recorder player Maurice Steger. The success of his CD's are reflected in hundreds of pages of listener comments which are posted on the Plaintiff's website. He also produces records for other artist (e.g., www.angeloangelo.com).

- 5. Plaintiff travels extensively throughout the world, performing and meeting people. He believes his work stands for friendship, dialogue, peace, harmony, understanding, cooperation, cultural exchange, equality of all people, and other positive values. Plaintiff has always condemned acts of violence and incivility.
- 6. Plaintiff was born in Tehran, Iran and lived in the USA since age 15 where he obtained magna-cum-laude Bachelors in Computer Science and Philosophy, and an MBA from major California universities. He worked extensively in Information Technology before pursuing a full-time music career serving world-class private, public, government, and non-profit organizations. He studied the music privately since an early age with teachers including some of the most famous guitarists in the world.
- 7. Plaintiff has never sued anybody nor has he ever been sued. He has always strived to resolve differences peacefully and in this case too; towit, he pleaded numerous times to the Defendants to stop their violations and to come forward to resolve the matter peacefully. But the pleas were viewed as sign of weakness and were reciprocated by insults (reference: rmcg #233583, #234325). Plaintiff did everything in his power to avert having to take this legal action, as he believes, and it has proven, that it takes tremendous energy, health, time, and money to litigate, and such resources could be put to better use, for creative, productive, humanitarian, and charitable efforts. Plaintiff hopes that this case will serve as yet another example that Cyber abuse will not go unpunished, a fact that many Internet abusers still do not grasp.

- 8. Despite having had the technical skills, the Plaintiff did not try to get even with the Defendants on their terms and did not do anything uncivil in response to the Defendants' violations, in line with Einstein's belief that "you can never solve a problem on the level on which it was created".
- 9. References regarding Plaintiff's performances and recordings (over 100 pages of listener comments), as well as character references are available. Plaintiff has tried all his life to live a correct life and as a result has built and enjoyed a good reputation, which the Defendants strived to destroy. Exhibit 6 is one testimony to the success of his CD, "In Friendship", by a very credible source.

DEFENDANTS & THE CLASSICAL GUITAR NEWSGROUP

- 10. The Defendants used the rec.music.classical.guitar Usenet newsgroup (currently owned and operated by Google Incorporated) as a venue to commit many of their violations. This is very likely the largest online classical guitar discussion group and has readership and participation from hundreds of guitar enthusiasts, world-wide. Several, if not all of the Defendants have published messages on this forum.
- 11. Records posted on Usenet, as with much of the other contents of the Internet, have a permanent nature since there archives of archives exist online. Also, when people reply to messages and for example, quote a fraudulent message, the fraudulent message getting falsely attributed to an author gets copied and proliferates.

- 12. Plaintiff is not presently aware of the true names, identities, or capacities of Defendants DOE 1 through DOE 10, nor of the address of the non-DOE Defendants. The Defendants are known to the Plaintiff by their email address, and the Internet Protocol ("IP") address assigned to each one by his or her online service provider on the date and time at which each infringing activity was observed.
- 13. At all relevant times, each of the Defendants may have been associated with the remaining Defendants, thus acting in concert with or as agent, co-conspirator, inspiration or motivator of each of the remaining Defendants and was at all times herein mentioned, acting within the course, scope, purpose, consent, knowledge, ratification and authorization of such agency, association, cooperation and conspiracy.
- 14. By means of the Internet, the actions of Defendants, as described in this complaint, occurred in California, in other States of the United States, and in countries throughout the world.
- 15. The Plaintiff deleted some of the forged messages that had used his email address but some of those may still exist on mirror sites that take archive of archives. Also several messages are still online: messages that the Plaintiff could not delete because the authors did not use his email address but nonetheless forged his writing as replies to messages he did not write which were presented as his writing. Plaintiff will also beg this Honorable Court, following the filing of this complaint, to issue orders to likes of Google Inc., to delete forged messages from the online archives.

identity in the manner described presently through unauthorized use of Plaintiff's name and email address and possibly a mock password all in violation of the Identity Theft and Deterrence act, Title 18 U.S.C. § 1028.

23. During this period, Sixteen (16) messages were published on the Internet by Defendants who used the Plaintiff's name, email address and possibly a mock password to present themselves as the Plaintiff: ["Reza Ganjavi (www.rezamusic.com) " <ganjavi@dtc.ch>]. These messages were not written by the Plaintiff. Inarguably the combination of four identity features, i.e., first name, last name, website URL, and email address very uniquely and unambiguously identify the Plaintiff. Plaintiff has in the past used the same set of attributes to publish material on the Internet. While there are many persons named "Reza" in the world, to the best knowledge of the Plaintiff there are no other "Reza Ganjavi"'s, and even if there were, technically it is impossible to have another "Reza Ganjavi" with the email address: "ganjavi@dtc.ch" and even more impossible to have anybody with any name who can claim to be the "Reza" referred to by "www.rezamusic.com" as the Plaintiff is the sole and legal owner of this website URL. Therefore, using a combination of these identity features uniquely and unambiguously identify the Plaintiff, and it is this exact combination which the Defendants used to pose as the Plaintiff, and publish material with the Plaintiff posed as the author. Furthermore, Defendants may have forged the Plaintiff's password in order to post messages as the Plaintiff.

24. During this period there was no way to stop the recurrence of such violations as the Usenet/Internet does not provide such technical facility. Anybody can go online and post as anybody else. It is common sense that not only such behavior is not civil, it is fraudulent. Within matter, the

1	Defendants intentionally and maliciously used the Plaintiff's identity,
2	without the Plaintiff's authorization, to post messages that the Plaintiff

- g) Using the Plaintiff's identity, directed many obscene remarks to the Plaintiff and others
- h) Using the Plaintiff's identity, directed racial slurs including publicly publishing a message with the tile: "THIS IS WHY BLACK PEOPLE ARE NIGGERS" (Exhibit 5) containing a link to a picture of a Black person. This is absolutely and unquestionably against the Plaintiff's belief. Plaintiff understands that "group libel" is not an actionable offense, however, falsely attributing such insult to the Plaintiff as the source is a violation of his rights. Plaintiff has utmost respect and affection for the Black race especially, as he does for civil fellow human beings of every race, ethnicity, country, gender, and religion, and in addition Plaintiff has many Black friends and fans

- 33. On or about August 5, 2005, and September 11 2005, it was brought to the Plaintiff's attention that the Defendants had set up mock websites strongly resembling the Plaintiff's registered websites in name, design, and content.
- 34. One mock website hosted on Yahoo/Geocities (Exhibit 5) referred explicitly and unambiguously to the Plaintiff in both text and photo, endorsed products that the Plaintiff did not endorse, directed insults and invectives at the Plaintiff and his products and services, putdown his professional competence and offended the Plaintiff's potential customers. This website was announced by a DOE Defendant who posed as "Official Moderator <moderator@rmcg.com>" (Exhibit 5).
- 35. The site also directed sexual slurs towards the Plaintiff and his business associates, implying that the Plaintiff was a homosexual, which he is not. This last allegation is important because Plaintiff travels to Iran, where his relatives still reside. In Iran, homosexuality is a crime and is severely punishable, so posting this false allegation on the Internet is especially dangerous for Plaintiff and harmful to him.
- 36. The aforementioned mock site was announced to the Plaintiff On September 11 2005, from IP address [24.148.29.235] which indicates that the Defendant maybe a customer of RCN. The Defendant wrote: "You and I share similar interests and even look alike. www.geocities.com/rezasworld". On the same day the site was also announced publicly (Exhibit 5). The site's visit-counter indicated the site was visited by at least 99 visitors. From the same email address, a day later, the Plaintiff got an email: "Care to negotiate a peace settlement?" but this one was from the IP address

[167.219.0.140] which indicates that the Defendant maybe an employee of Deloitte's (Exhibit 5). It is plausible that this DOE Defendant works for Deloitte and uses RCN as home online service provider. Both Deloitte and RCN have been notified about the violations. Plaintiff also noticed that his online journal visit statistics show an obsessive number of visits from both Deloitte (Exhibit 2) and RCN (Exhibit 3), as well as Time Warner Cable / Roadrunner (Exhibit 4) - the same online providers and IP addresses from which many violations discussed in this action occurred.

37. On August 4, 2005, another mock site (Exhibit 5) hosted on Homestead, was publicly announced by Todd Tipton (Exhibit 5) using Time Warner Cable / Roadrunner ISP. Todd Tipton's own website (www.toddtipton.com) is also hosted on Homestead. The mock site maliciously impersonated the Plaintiff, misrepresented the Plaintiff's beliefs, and insulted the Plaintiff, his family and friends.

38. These False Presentations violated Section 43 of the Lanham Act, 15 U.S.C. § 1125, insofar as Plaintiff did not authorize, broker, sell, or otherwise license the right to use his name, image, professional reputation, to Defendants, or any of them. The Plaintiff requested the hosting companies to pull down the mock websites. The sites were deleted after being online for several days and attracting numerous visitors.

39. As a result of the foregoing, Plaintiff has suffered injuries to himself, his profession, his reputation, his artistic career, his health, and his relationships, in an amount to be determined at time of trial, but within the jurisdictional limits of this Court. In the alternative, Plaintiff prays for statutory damages for each violation of his trademark.

23	44. On 7 Jul 2005, Defendant Todd Tipton published a statement which the
24	Plaintiff had not written as the Plaintiff's writing while uniquely
25	identifying the Plaintiff as the author of the quoted text. The statement
26	offended and insulted the group members (Exhibit 5). On 7 August 2005 Todd
27	Tipton emailed the Plaintiff confessing to having setup the mock website
28	hosted on Homestead as discussed in the Second Cause of Action hereinabove,

and to the 7 July 2005 statement he published which was falsely attributed to the Plaintiff. He asked for forgiveness but since there are a number of DOE's who have committed numerous, serious violations very similar to Todd Tipton's, using the same ISP, and some from the same region as him, and they are not yet identified, he was notified by the Plaintiff that the Plaintiff can not take partial action and all Defendants need to be identified before any resolution can be discussed. The Plaintiff had no reason to trust that he would not repeat his actions without a formal restraining order or agreement.

45. Using the screen name (John Ed Gore <gore0026@3dm.net>), a DOE Defendant published appalling statements which the Plaintiff had not written were published as his writings four times, uniquely identifying the Plaintiff as the author of a quoted text.

46. Using the screen name (Rosa <rosa@rosarosa.soup>), appalling statements which the Plaintiff had not written were published as his writing six times, uniquely identifying the Plaintiff as the author of a quoted text.

Defendant William David Jennings using DataFoundry / Email.com

47. William David Jennings has used multiple aliases to publish material that have violated the Plaintiff's rights and placed the Plaintiff in False Light. To get a glimpse for his character, here's a quote from a message he posted on 26 October 2005 titled: "Pinging the Cybertroll Administrator": "I'm walking out the door headed for Mexico where I'll eat a dead kid

tonight"! He further encourages villains known in the Newsgroup as "Cyber Trolls" to act.

48. On several occasions 20 December 2004, the Defendant fraudulently presented writings the Plaintiff had not written as those of having been authored by the Plaintiff, explicitly and uniquely identifying the Plaintiff by his first, last name, email address and website URL. Defendant also negatively misrepresented sales on the Plaintiff's CD's.

49. On 28 December 2004, two times, the Defendant fraudulently presented writings the Plaintiff had not written as those of having been authored by the Plaintiff, explicitly and uniquely identifying the Plaintiff by his first, last name, email address and website URL. Defendant also attacked Plaintiff's CD, falsely relating Plaintiff to "Pink Striped Pajamas Gang of Abu Ghraib", "the gay scene in Tehran", and in one of the messages, made ethnic slurs, and lied about the functionality of certain links on the Plaintiff's website that refer to the product reviews.

50. On 28 December 2004 and on 29 December 2004 the Defendant fraudulently presented writings the Plaintiff had not written as those of having been authored by the Plaintiff, explicitly and uniquely identifying the Plaintiff by his first, last name, email address and website URL. Defendant also heavily attacked Plaintiff's CD, resembling it to weapons of mass destruction.

51. On 13 September 2005 the Defendant fraudulently presented writings the Plaintiff had not written as those of having been authored by the Plaintiff, explicitly and uniquely identifying the Plaintiff by his first, last name,

email address and website URL. The message fraudulently presented the Plaintiff as having requested the Defendant to write a song for him and the song lyrics included the hate lines: "I'd sooner see your neatly smoked carcass hanging on a meat hook in Hell."

52. On 31 October Mr. Jennings wrote a review about the CD. While the Plaintiff fully respects the freedom to hold opinions, Mr. Jenning's review went far beyond expressing opinions. He lied and misrepresented the CD as follows:

- a) Lie 1: "I listened to Reza's CD one time. On the second repeat of Spanish Romance I began to cringe ...after hear 6 (SIX) repeats of the same song with different titles (which indicates a clear lack of creative distinction) "Spanish Romance" (with flute and guitar) is played yet again as "Sunset At The Alhambra"...
- b) Fact is there is more difference between the variations than just the title. The melodies of the lead instrument is different in every single piece.
- c) <u>Lie 2:</u> "Reza's CD's are not sold in stores and have almost no distribution... occasionally sold in small Swiss music stores."
- d) This is false as the Plaintiff's CD's (a) are sold in some stores and do have distribution, both physical and digital; (b) in Switzerland, the physical distribution includes large stores.
- 53. Two times on 7 July 2005, on 8 July 2005 and 31 October 2005, the Defendant fraudulently presented writings the Plaintiff had not written as those of having been authored by the Plaintiff, explicitly and uniquely identifying the Plaintiff by his first, last name, email address and website URL. These messages self-attack the Plaintiff's products, person,

personality, education, skills, and etcetera. The messages are linked to the Defendant as he has consistently identified himself as the owner of "seadrifter@email.com" and often signs emails from this and "journey@texas.net" as "Che' de Guy".

Defendant Douglas Carlson using Hotmail, Everyone's Internet (EV1), etc.

54. Defendant Douglas Carlson, using "hogrider7@hotmail.com" has repeatedly bashed the Plaintiff's CD's which the Plaintiff has no problem with until the line is crossed into violating his rights. There is evidence that he has collaborated with some of the above named Defendants on occasion. He has repeatedly accused the Plaintiff of being homosexual, and also of having engaged in crude sexual acts, all of which are untrue.

- 55. The Defendant made one such remark in a message he posted on 14 December 2004 (#232976). On 4 August 2005 (#263108) he published a message that the Plaintiff has no testicles.
- 56. On 27 December 2004 (#234260) the Defendant associated the Plaintiff with terrorism (which is absolutely and utterly false) and suggested that he should be reported to the FBI. His reasoning for this was that the Plaintiff was born in Iran!
- 57. On 13 September 2005 the Defendant assaults Plaintiff's professional qualification as a guitarist. (#256125).
- 58. On 21 December 2005 (#233782) Defendant falsely accused the Plaintiff of being a racist and of other lies, which are absolutely false. He also

asserted that the Plaintiff has no other place for promotion other than the newsgroup which is absolutely false and he well knows it but lied about it to be malicious.

59. On 1 November 2005 (#259225) Defendant wrote about the Plaintiff's CD, "In Friendship" published more false statements about the Plaintiff's education and sexual orientation, and accused the Plaintiff of having a Sexually Transmitted Disease (absolutely false). He continued: 'Pepe of the Gay Mexico City Quartet said, "Reza spent a night playing with us, I only wish he would have brought his guitar with him", Jose also of the Gay Mexico City Quartet added, "its not my fault he got the STD, he's the one who wanted it bareback.'

- 60. Defendant finishes the messages by fraudulently presenting a quote that the Plaintiff never wrote as having been authored by the Plaintiff in which the Plaintiff talks about lack of customer satisfaction in his product (statistically false).
- 61. Note: Everyone's Internet has at times used PacWest and Adbasesystems.com to lease lines or buy ports for dialup.
- 62. As a result of the foregoing, Plaintiff has suffered injuries to himself, his profession, his reputation, his artistic career, his health, and his relationships, in an amount to be determined at time of trial, but within the jurisdictional limits of this Court.

The Defendant defended his action upon questioning from a fellow group member (and Professor) by responding: '...what kind of crap is it when he says "this email message is the property of the author " etc. Once I received it it was mine to do with as I pleased.' totally disregarding the intellectual property law which was clearly reiterated to him.

106. On 13 September 2005, a DOE Defendant illegally assuming the identity of the Plaintiff as described under First Cause of Action, sub-section "o", altered and posted Plaintiff's copyrighted material without permission (Exhibit 5)

107. As a result of the foregoing, Plaintiff has suffered injuries to himself, his profession, his reputation, his artistic career, his health, and his relationships, in an amount to be determined at time of trial, but within the jurisdictional limits of this Court. In the alternative, Plaintiff prays for statutory damages for each violation of his copyrights.

108. Plaintiff will suffer immediate and irreparable harm if this Court does not order injunctive relief, in that his business, practice, and artistic reputation will be taken from him.

109. Plaintiff has exhausted his administrative remedies.

ELEVENTH CAUSE OF ACTION

(Transportation of Obscene Matters 18 U.S.C. § 1462)

4 110. Plaintiff incorporates by reference all allegations contained in any preceding paragraph, as though fully set forth here.

111. The content of several instances of written communication posted on the nationally, cross-state, and globally accessible Usenet system, was highly obscene, lewd, lascivious, and filthy. These communications were directed towards the Plaintiff, or directed at others while the Defendant posed as the Plaintiff uniquely identifying himself as the Plaintiff. Exhibit 5 contains several instances of such communication which incidentally, is also available to minors, and there have been cases of minors who have read, posted, and communicated on the Usenet group in question.

112. As a result of the foregoing, Plaintiff has suffered injuries to himself, his profession, his reputation, his artistic career, his health, and his relationships, in an amount to be determined at time of trial, but within the jurisdictional limits of this Court. In the alternative, Plaintiff prays for statutory damages for the transmission of the extremely obscene material over the Internet across the United States and globally.

113. Plaintiff will suffer immediate and irreparable harm if this Court does not order injunctive relief, in that his business, practice, and artistic reputation will be taken from him.

1	114. Plaintiff has exhausted his administrative remedies.

4	PRAYER FOR RELIEF

6	WHEREFORE, Plaintiff prays judgment against Defendants as follows:

8	1. An award of actual damages fully compensating Plaintiff for all



In my capacities as a composer, I was asked by Mr Ganjavi to write some melodies upon a popular piece for solo guitar, composed in an undefinite time on 19th century, and called in Spanish "Romance Anonimo" - because its author is so far unknown.

I wrote on 1999 seven different melodies, all of them having in common "Romance Anonimo" used no longer as a solo piece, but as an accompaniement. Each of the seven melodies was written for an instrument to be played in duo with the accompanying quitar.

Subsequently, Mr Ganjavi recorded the whole set of works - entitled "Canzoni dimenticate". Like all my compositions, they were published and copyrighted by Edizioni Musicali Bèrben, Ancona, Italia.

From such a recording, I have received from SIAE (Società Italiana 19 20

Autori ed Editori) a share of royalties which makes me quessing that the record in question was produced in rather a high number of copies - considering the usual amount of copies for a record of classical quitar - in the order of some thousands.

Mr Ganjavi showed me a series of statements which warmly praised his CD.
