Posted ten messages that I had not written as my writing using my stolen email address and website to uniquely present me as the author (From: “Reza Ganjavi (www.rezamusic.com)” ganjavi@dtc.ch). The messages contained many insulting remarks and racial slurs including use of the “N” word to refer to my black fellow human beings and other remarks exhibiting racial prejudice, making sexual threats to others, sexual insults and inappropriate and false remarks towards myself, making inappropriate sexual overtures to others, attacking a civilized member of the community, falsely discarding what I actually had written as not being my writing, and altering and posting my copyrighted material without permission.
